Role Purpose

The Spray Technician is a member of the Green Team within the Potted Plant Production business. This role is responsible for:					
1.	To coordinate and execute spray and drench applications in a safe and effective manner and in accordance with Riversuns standard operating procedure, ensuring all activities are carried out in the most efficient manner possible while also maximizing plant health, plant recoveries and staff wellbeing.				
2.	As directed by the Green Team Supervisor assist in daily Green team / General Nursery activities.
